## SPEAKERS BIOGRAPHIES

**Dr. Rebecca Wartman** attended The University of the South and University of Missouri St Louis School of Optometry. She is in private practice caring for nursing facility patients in western North Carolina. Dr. Wartman is a past President of the North Carolina State Optometric Society and currently serves on the NCSOS Third Party Committee and American Optometric Association Third Party Center Executive Committee. She is the American Optometric Association alternate advisor to CPT Editorial Panel. She writes and lectures on insurance and coding issues as well as Long Term Care Eye Care. She serves as a Board member and advisor to Doctors Vision Center OD PA and as medical director for Trident Mobile Clinical Services Eye Care.
